Connect2Help(TM) facilitates connections between people who need human services and those who provide them. Individuals and families need to know where to call for assistance in times of difficulty. However, they are often unable to obtain available services quickly and easily due to a lack of knowledge and/or fragmentation of the service delivery system. The purpose of Connect2Help is to help people find their ways to available services ranging from food banks to crisis assistance and everything in between.

Connect2Help personnel, staffing their 24 hour/day, 7 days/week, 365 days/year 2-1-1 Call Center, answered 275,140 from area residents from 35 Indiana counties who were seeking social services assistance. These callers reported 345,972 needs. In response, Connect2Help Information & Referral Specialists provided 466,921 referrals to non-profit, governmental and faith-based social services programs. Among those surveyed after their original calls, 85% followed through with the suggested referrals. Among those who followed through, 78% reported that they had improvements in their situations.

Connect2Help211 maintains an informational database of social services programs that serve residents living in 69 Indiana counties (60% more than last year) . This database includes 4890 non-profit, governmental and faith-based agencies (22% more than last year) providing 10,698 programs (14% more than last year). In a year when money for helping our community one at a time on the phone was very hard to attract, Connect2Help211 used this informational database to serve 215,981 people (59% more than last year) making 229,044 web searches (29% more than last year) through its website at www.connect2help211.org, along with using the same information to serve clients calling Connect2Help211 for assistance. Finally, the database is use to provide 8268 downloads of Rainbow BookS(tm), local directories of agencies and services provided by those agencies (9% more than last year) which are available for free download at www.connect2help211.org.

Knowing that many 2-1-1 callers are eligible for SNAP benefits and that in Indiana many people who are eligible for SNAP were not currently participating, Connect2Help 211 and other Indiana 2-1-1 agencies launched a SNAP "in-reach" program. As part of this program, Information & Referral Specialists asked 142,482 incoming callers if they were currently participating in the SNAP program. 6,838 clients were pre-screened for SNAP eligibility and referred to SNAP and other food resources, like food banks.
